New Delhi: The Congress had vociferously opposed the Aadhaar legislation brought by the Narendra Modi government as well as linkage to various schemes, but the Madhya Pradesh government run by the party has adopted its faith in Aadhaar and made linkage to mandatory for farmers seeking to avail themselves of the recently announced loan waiver.

"The amount will be deposited through Direct Benefit Transfer (DBT) from the state exchequer into the farmer's loan account. Hence, to avail the scheme's benefit, it is mandatory for the farmer to get his bank account seeded (linked) with Aadhaar," said an order issued by the MP government on January 7, a copy of which was seen by ET.

Guwahati: Three of the nine members nominated by the Union home ministry may not join the panel for implementation of Clause 6 of the Assam Accord.

Nagen Saikia, former president of Assam Sahitya Sabha, has announced he will not be part of the MHA committee.

Saikia said: "It's a cabinet-constituted committee and so once the government changes the recommendation of the committee will not mean anything. The life and tenure of the committee are uncertain. Also, by keeping this committee in front, the government wants to pass the Citizenship Amendment Bill, 2019. Another ex-president of Assam Sahitya Sabha, Rongbong Terang, is also not likely to be part of the panel. Earlier, senior lawyer Parag Mehta had refused to be part of the committee, saying the Union cabinet's decision to constitute a high-powered committee as nothing but an attempt to divert attention of the people from Citizenship (Amendment) Bill 2019.

## Citizenship Bill May Help BJP in Bengal

Kolkata: The Citizenship Bill might have dampened the prospects of BJP in the northeast, but it is expected to brighten the party's future in West Bengal.

BJP hopes to add at least 10 million Hindu Bangladeshi refugees to its vote bank if the Bill is implemented. It will also help BJP cleanse its anti-Bengali image that had become a perception issue for the party following the NRC process in Assam. Professor Mohit Roy, chief of the committee, saying the Union cabinet's decision to constitute a high-powered committee as nothing but an attempt to divert attention of the people from Citizenship (Amendment) Bill 2019. Assam is one of signatories of Assam accord, signed after six-year agitation in 1985. The citizens committee had asked the members of the committee to refrain from it or they will face social boycott. Assam chief minister Sarbananda Sonowal and finance minister Himanta Biswa have requested Assu to refrain from it. Clause 6 provides constitutional, legislative and administrative protection to cultural, social, linguistic identity of the people of Assam.

# India Offers Scholarships to 400 Syrian University Students to Study in India

New Delhi: India has offered fully-paid scholarships to 400 Syrian university students to study at various universities across the country. The West Asian nation is slowly getting

back to normalcy after seven years of counter-ISIS operations. ET has learnt that most Syrian students for undergraduate and post-graduate courses have arrived in India as part of the initiative. This decision, first of its kind, was designed and conceived to develop closer bonds between the two countries as

the Assad government has successfully thwarted terror group ISIS. As part of its goodwill gesture, the government has provided flight tickets to all these students. For over five decades now, India has been offering capacity-building courses to students and professionals of developing countries.

"This was a special gesture which was extended due to Indo-Syrian political ties. India has stepped up its engagement with Damascus as the situation is returning to normal in most parts of Syria," a person familiar with the West Asian developments told ET.

New Delhi, which supported the Assad government in its fight against ISIS, is seeking to re-launch its economic and soft power engagement with Syria. High-level political engagements are also in the offing over the next few months.

India has extended its strong support for the sovereignty and territorial integrity of Syria, which, on its part, has provided support on the Kashmir issue on all international forums, including the Organisation for Islamic Cooperation, and believes India has the full right to take action if it deems fit following any cross-border strike.

As part of economic engagement, nearly 100 Indian companies partici-

ated in an industrial fair that was hosted in Damascus last year of credit under the operation, and believes international has modernised a steel plant and BHEL is executing a project there. Damascus is also willing to offer phosphorus, bauxite and exploration in the Syrian desert zone.
