Sub: Particulars of Equity Shares which have been extinguished and destroyed pursuant to the Buy-back of equity shares ("Equity Shares") of Delta Corp Limited ("Company") from the open market through stock exchange route ("Buy-back") by the Company, in accordance with Regulation 24 (iv) of the Buyback Regulations.
